1. General description

The 74HC1G14; 74HCT1G14 is a single inverter with Schmitt-trigger input. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} . Schmitt trigger inputs transform slowly changing input signals into sharply defined jitter-free output signals.

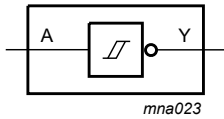


Fig. 1. Logic symbol

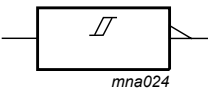


Fig. 2. IEC logic symbol

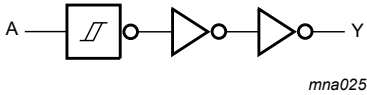


Fig. 3. Logic diagram

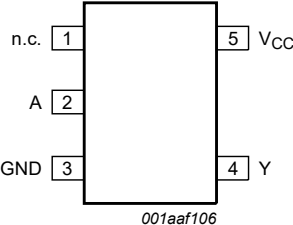


Fig. 4. Pin configuration SOT353-1 (TSSOP5) and SOT753 (SC-74A)

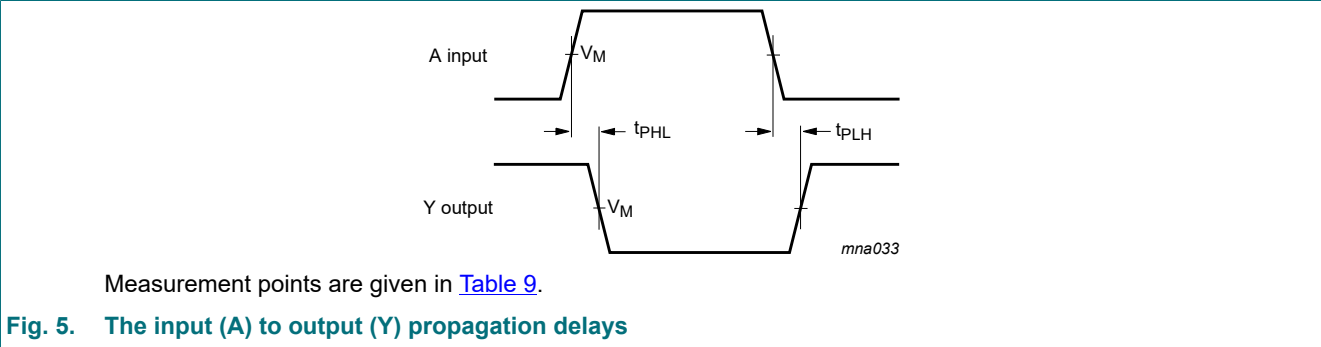
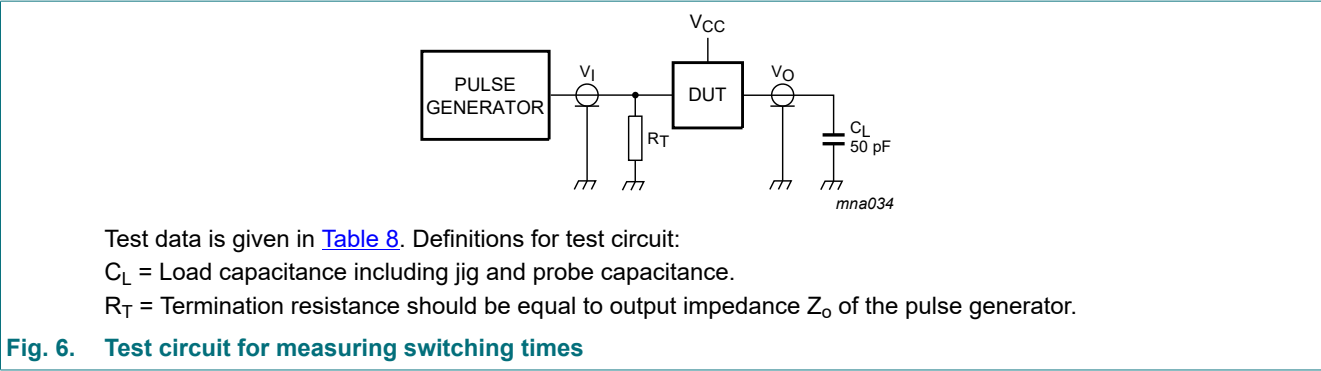
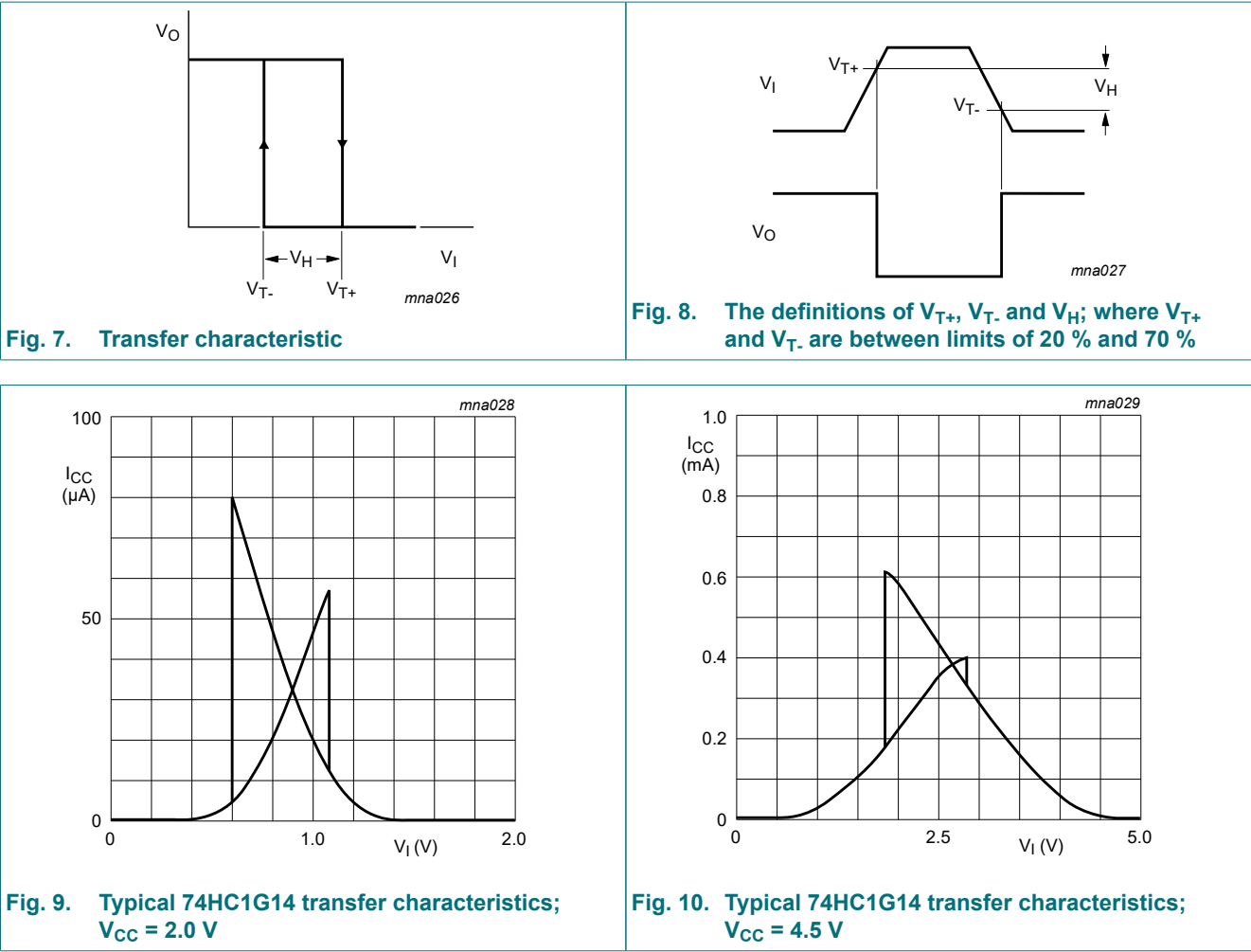

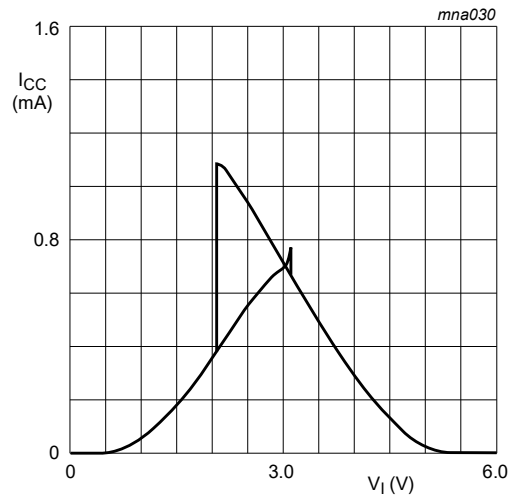


Fig. 11. Typical 74HC1G14 transfer characteristics; $V_{CC} = 6.0\text{ V}$

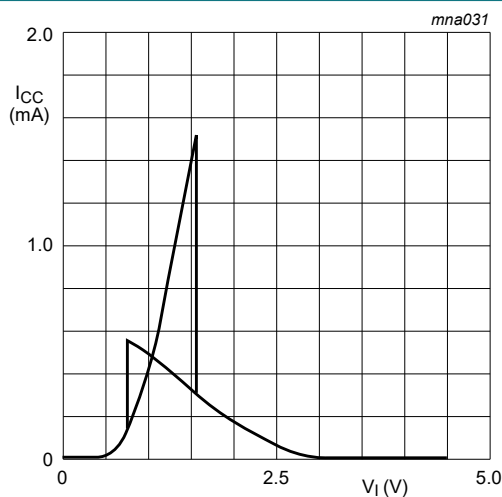


Fig. 12. Typical 74HCT1G14 transfer characteristics; $V_{CC} = 4.5\text{ V}$

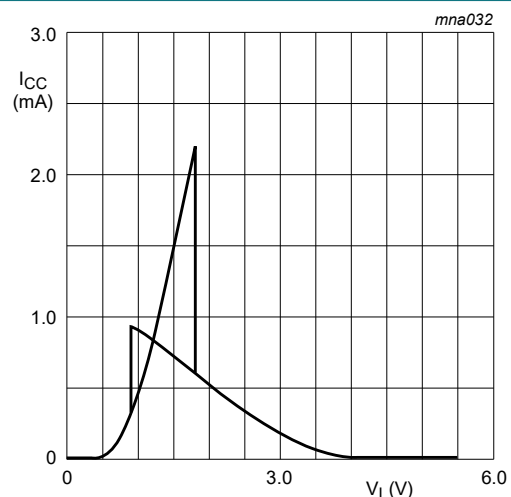


Fig. 13. Typical 74HCT1G14 transfer characteristics; $V_{CC} = 5.5\text{ V}$

13. Application information

The slow input rise and fall times cause additional power dissipation, this can be calculated using the following formula:

$$P_{\text{add}} = f_i \times (t_r \times \Delta I_{CC(\text{AV})} + t_f \times \Delta I_{CC(\text{AV})}) \times V_{CC}$$

Where:

P_{add} = additional power dissipation (μW)

f_i = input frequency (MHz)

t_r = rise time (ns); 10 % to 90 %

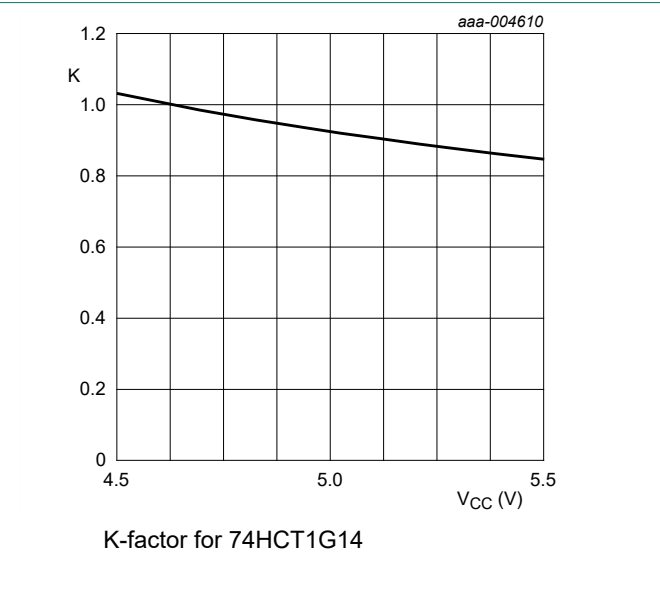
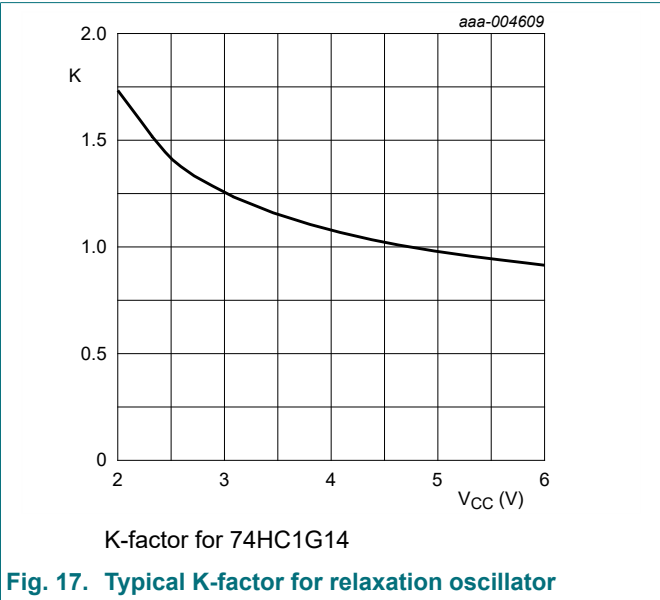
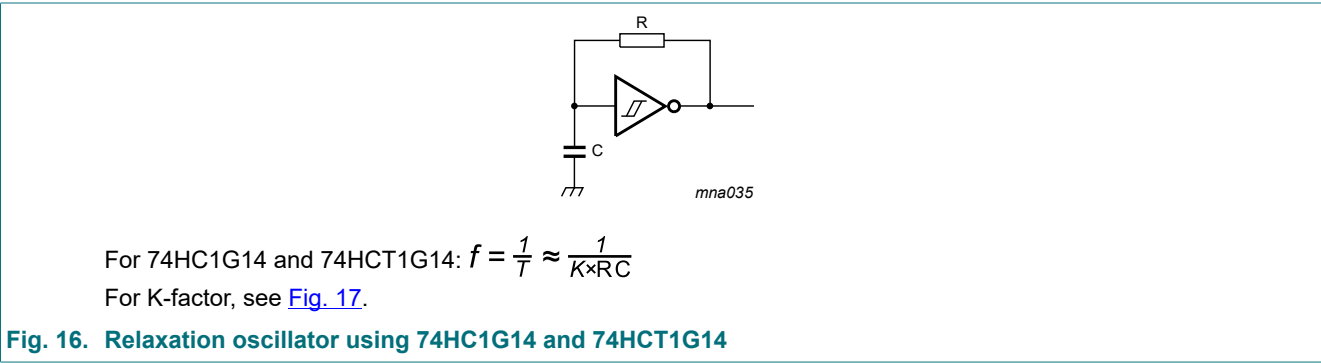
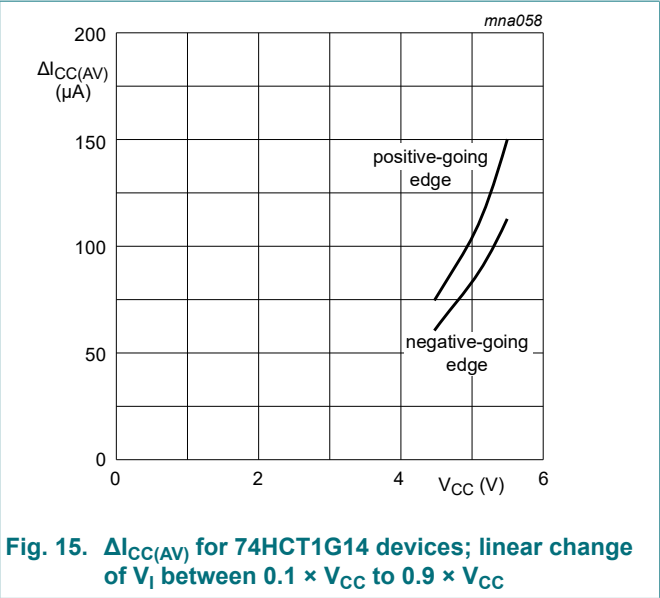
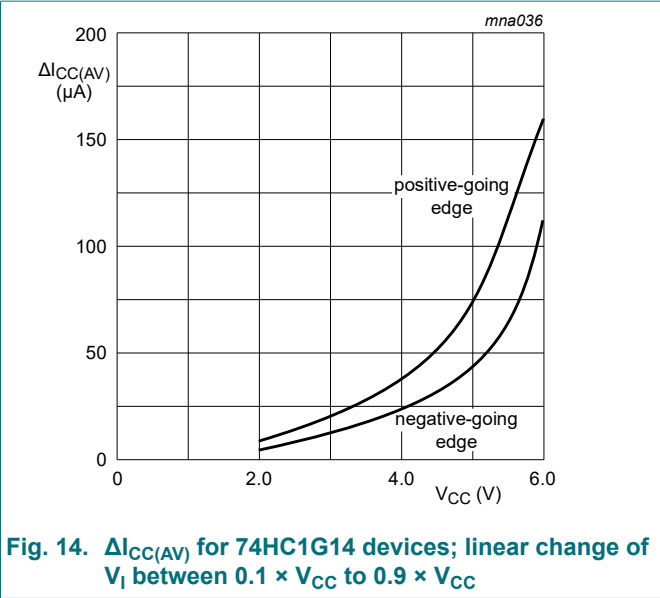
t_f = fall time (ns); 90 % to 10 %

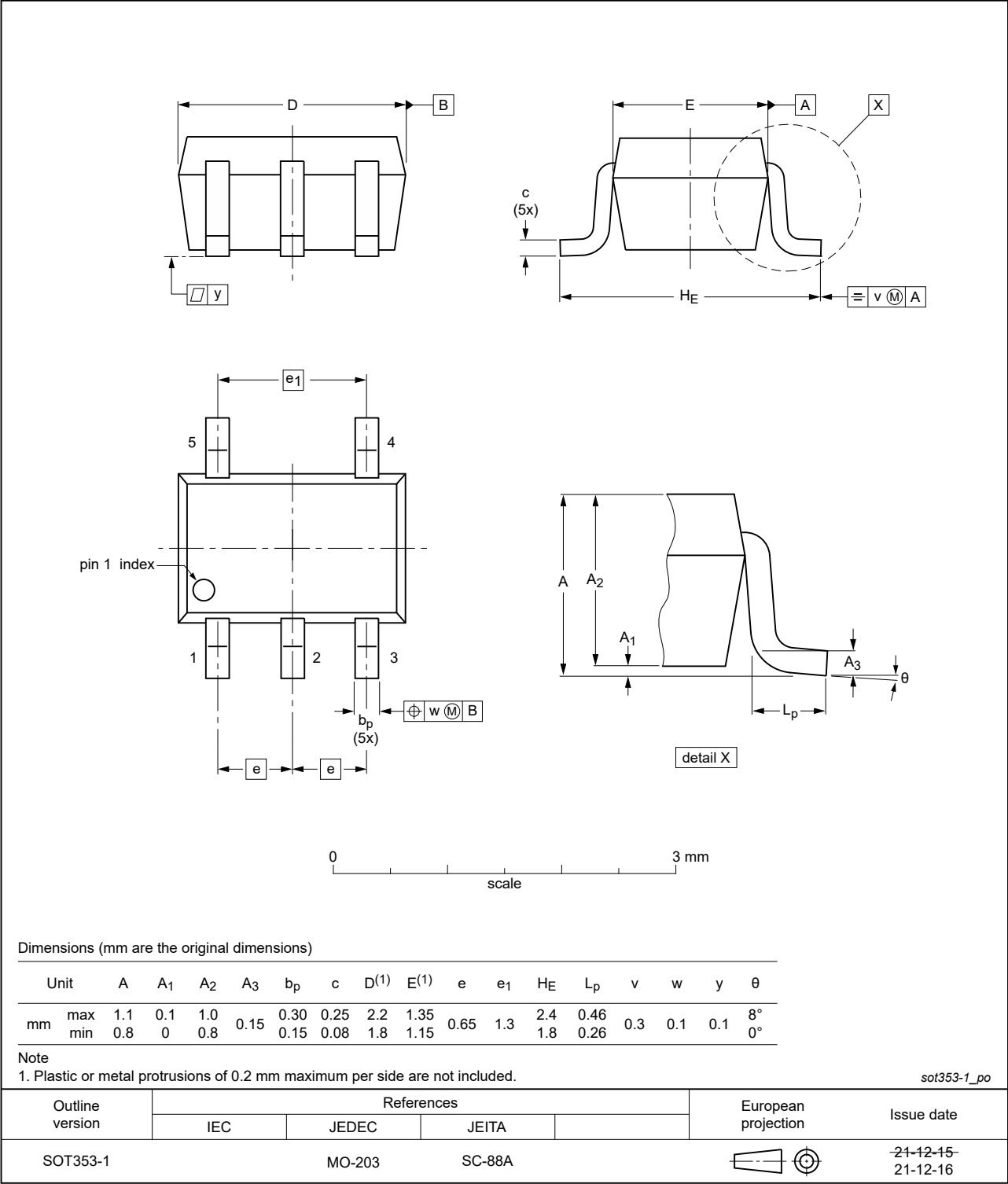


Fig. 18. Package outline SOT353-1 (TSSOP5)

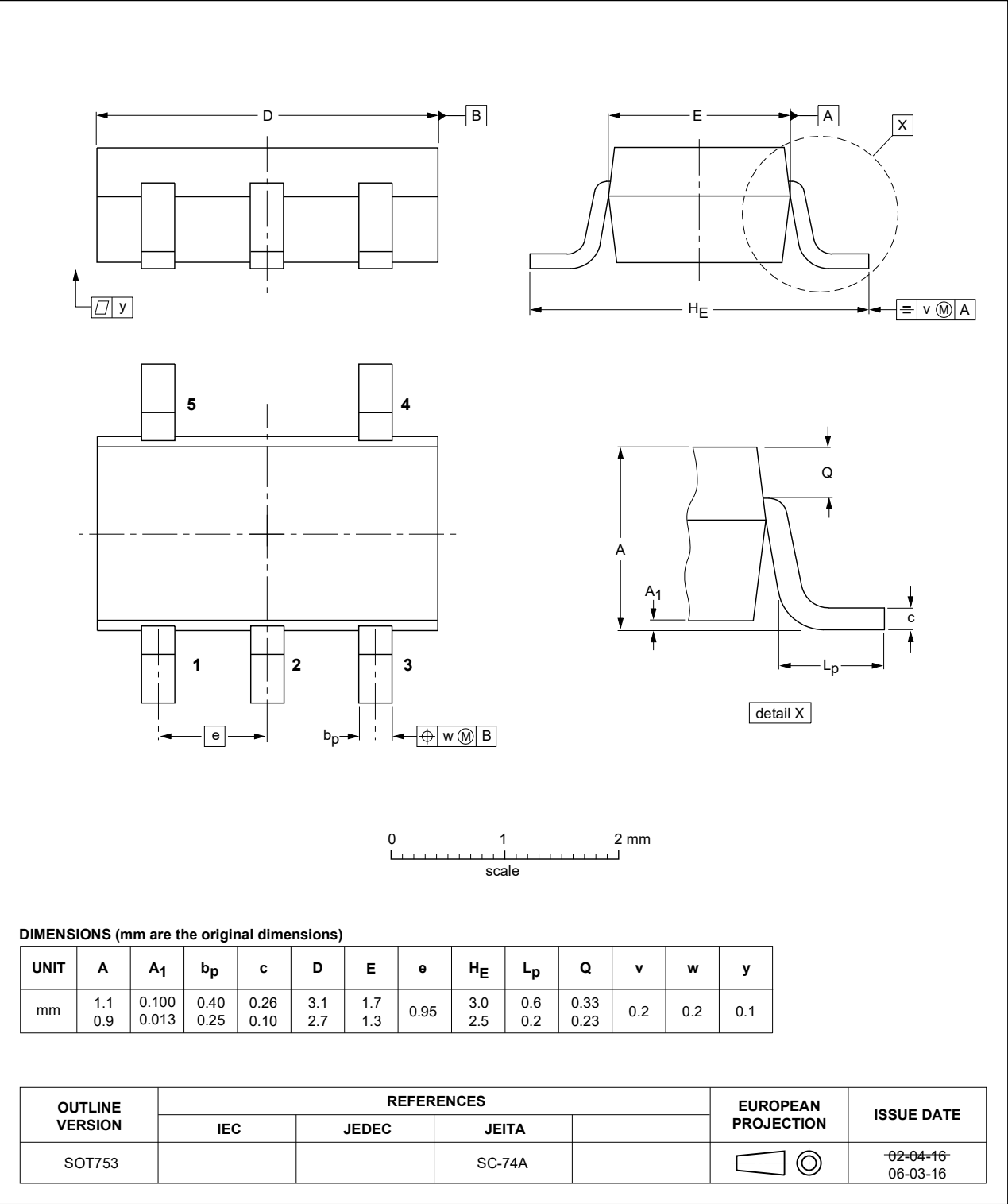


Fig. 19. Package outline SOT753 (SC-74A)
